Business Spotlights

- 1. FCEDC Future of Fulton County Program Eric Smola
- 2. All eight school officials have developed a program focused on preparing kids for the work force. Their focus is the kids who don't have a plan.

- 3. The program is for juniors and seniors and each school can send up to four students.
- 4. Students attend their core classes in the morning and the program in the afternoon.
- 5. 1st semester is dedicated to teaching soft skills such as interviewing, writing a resume, handshakes, etc. Students will also go through certification courses such as OSHAA, AED and more.
- 6. 2nd semester is dedicated to on-the-job opportunities. Students will be paired with a participating business in the field they are interested in.

Guest Speaker – Cathy Mossing, Village of Metamora

- 1. Rick Meiring was unable to attend, but the newly formed Tree Commission has been busy over the past year.
 - a. They have inventoried each tree in the right-of-way areas, the park and other common areas where the village is responsible for the trees.
 - b. Their inventory includes tree varieties, condition and current maintenance needs.
 - c. The Tree Commission is also responsible for the planning of our Arbor Day each September. Third grade classes are invited and have a blast. The Gleaners sponsor lunch and the kids then witness the proper planting of a tree and can ask questions.
- 2. New playground area was completed last fall near shelter c and the t-ball field. Grant money was received, but Anderzack-Pitzen and the local cub scout group and their parents did much of the grunt work.
- 3. Creek cleaning will resume any time now.
- 4. The Garnsey bridge failed inspection this year. It is still safe but does qualify for us grants that will cover the bulk of the engineering and construction which is predicted to begin sometime in late 2028. One lane will remain open during construction. This will include a new pedestrian bridge as well.
- 5. ODOT has been busy on the West Main Street bridge. We hope to have this project complete and the bridge back open sometime in December.
- 6. The Chamber planters have changed from summer flowers to mums for this fall. Thank you to the Farmer's Wagon for sponsoring the mums. If your business would like to sponsor either of the plantings for 2026, please contact the chamber. A few more planters, butt cans and benches have been ordered for next year to complete the downtown business district.
- 7. The Village has received a grant to hire a professional to update the Zoning Ordinances and the Comprehensive Plan. Council and the Planning Commission will be reviewing documents presented by Jacob Barnes from Zoning Solutions to be sure they reflect the village's needs. Final approval will come from council via ordinance.
- 8. Our newest business, DM Creations, celebrated their first anniversary earlier this summer. If you have not stopped by the shop, you're missing out! Not only does she create awesome t-shirts, sweatshirts, mugs, koozies, hats, etc. for your favorite team, but Debbie also carries products from other local small

- businesses. You can purchase Fischer Honey, Bloponian Studios pottery, Green Bubble Gorgeous bath products and much more.
- 9. Tru Corner Commons has been busy gutting and replacing apartments in the two-story building at the center of town. As residents move out, Brandon updates the apartments before re-renting. He is also planning some façade improvements to the exterior.
- 10. ABT Real Estate & Holdings has received a façade grant. This grant will allow them to repair, restore and/or replace the facades of the Farmer's Wagon, Big's Bar & Grill and the old Arkam Office building.
- 11. Coming in 2026 will be the Wagon Wheel Java & Creamery where you can grab a coffee (with or without that something extra) or ice cream cone.
- 12. Also joining DM Designs and Wagon Wheel Java & Creamery in the Farmer's Wagon strip will be the Wagon Wheel Flower & Gift. Just like it's name, we will have a local florist and a place to buy some special gifts.

- 4. The board will continue to meet eight times (every month except the months that the chamber meets)

- 6. Eric also shared that House Bill 168 involving property taxes will have a huge impact on schools and communities. The school is posting information and links to further information on their Facebook page.
